Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I'm glad to hear the transfer of Gavin Peterson to Mountain View High School has resulted in him doing well in the classroom. He is a really nice young man that has had to overcome many challenges outside his control. Gavin attended Shelton High School from 9/2013 – 12/2015. During his attendance he struggled academically at times. He had little disciplinary history with no infractions since 2/2014. Athletically, he quit basketball in 2014, played varsity baseball in 2015 and quit wrestling in 2015. The only athletic code violation was being academically ineligible at one point. His last physical was completed 11/20/2014. While at Shelton Gavin did remarkably well considering the instability of his family. From Shelton High School's perspective there are no underlying issues that would prohibit him from participating in your athletic program other than what your state interscholastic athletic association requires. Athletics can be a hook to help our challenged students stay on track with their academic success and for Gavin this really is true. I hope it works out for Gavin to play baseball in this his final year of eligibility.
