



TO WHOM IT MAY CONCERN,

THIS LETTER IS IN REFERENCE TO LOGAN HALL'S ELIGIBILITY TO PARTICIPATE IN THE TRACK PROGRAM. IT HAS BEEN BROUGHT TO LIGHT THAT DUE TO A LACK OF CREDITS LOGAN WILL NOT BE ABLE TO RUN. LOGAN'S EXPERIENCE AT SOUTH SALEM HAS NOT BEEN SMOOTH. AS A SOPHOMORE LOGAN SUFFERED A SERVE RE CONCUSSION ON CAMPUS. DURING HIS RECOVERY, WHICH HAS TAKEN UNTIL THIS YEAR, LOGAN HAS STRUGGLED IN SCHOOL. THIS CAUSED HIM TO FALL BEHIND IN CREDITS.

LOGAN IS AWARE OF HIS ACADEMIC STATUS. HE HAS TAKEN THE NECESSARY STEPS TO INSURE THE MISSING CREDITS ARE MADE UP AND THAT HE GRADUATES ON TIME. HE IS WORKING HARD IN HIS CLASSES, AS WELL AS TAKING ON LINE CLASSES AND WORKING AS A PATIENT ASSISTANT IN PHYSICAL THERAPY.
