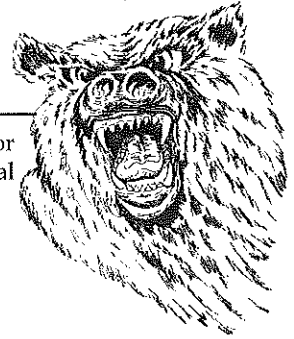

He had previously been living with his father and attending Yreka High School so he is currently ineligible due to a transfer without change of joint residence.

As reported by Payson and his mother, he did not want to move in the middle of his senior year. He preferred to finish high school with his friends that he had grown up with. Evidently, he felt the abusive situation he was living in with his father was unbearable and he could not tough it out to finish the year.

Payson has been a track athlete throughout high school and has been practicing with team. He is a solid student with good grades who is on track to graduate. Being a part of a team gives him an opportunity to be involved in school and make friends as a new senior. The circumstances of the move were beyond his control and should not block him from participation.

My Son Payson Collins came to live with me in November 2015. He moved because him and his Dad were having problems. The verbal and physical abuse were escalating to a point that Payson no longer felt safe in his home in Yreka. The belittling and name-calling were causing a depression in Payson to the point that I was afraid for his mental well-being.

Payson has gone to numerous counseling appointments and tried to do everything he could to make the situation in Yreka work, but the events between him and his Dad continued to escalate. The physical abuse was occurring more and more and Payson feared what was going to come next. Payson is a senior and will be graduating in June. Track has been his passion and it would mean a lot to him to have the opportunity to participate for the 2016 season here in Ashland.
