Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.



To Whom it may concern:

This letter is in regards to Carlyn Yeatts and her eligibility to participate on the Bend High Track Team.

Carlyn arrived at the Academy at Sisters, in Bend, Oregon, on May 15, 2015. She came directly from a wilderness therapy program which she attended for approximately 90 days. Carlyn's family sent her to the wilderness program due to her risky behaviors at home, poor family relationships, and using unhealthy coping skills to deal with her anxiety and depression. Carlyn successfully completed and graduated from her wilderness program, and her therapists felt it was in her best interest if she attended a therapeutic boarding school, which is how she arrived at the Academy at Sisters. Carlyn was immediately enrolled in school, which is part of the J Bar J learning Center and part of the Bend-Lapine School District.

Since Carlyn's enrollment at the Academy at Sisters, she has made many positive changes in her life. She earned enough trust that she was able to attend Bend Senior High school in February 2016. Carlyn has remained sober and continues to improve her relationships with her family. Carlyn has learned and implemented healthy coping skills to help with her depression and anxiety. Carlyn felt that joining the Bend Senior High Track team would help her continue on the path of making positive choices, by getting to know other peers that have positive goals and healthy extra-curricular activities. Carlyn advocated for herself to be allowed to participate on the track team, which is not something that the Academy usually allows. To me, this shows Carlyn's motivation to continue to make positive changes in her life, and develop new, healthy interests and activities. Carlyn has truly come so far during her stay here and made so many positive changes in her life.
