To Whom It May Concern:

I am a physician writing to provide documentation and collateral information in support of Laddie Wirth's request for hardship eligibility, such that he would be able to play sports as a high school senior in the 2016-17 school year.

I am a provider not for Laddie but for his mother, Janine. A serious health condition she was experiencing in the 2013-14 school year had a major impact on Laddie and significantly contributed to his inability to function academically that year. Janine has already provided information to you that documents Laddie's emotional/learning challenges. In addition to these, and intensifying his disabilities at that point, in the fall of 2013 Janine was thought to have a serious form of cancer. She was extremely ill for a number of months. During that period of time, Laddie failed every one of his classes and was unable to participate in sports. He essentially lost a year of his life as a student.

I hope this information is helpful to you. Thank you for your consideration of the Wirth family's request.




